### Annual Report 2016 - The founding year

On 12/09/2016 seven people from Munich founded the association "The Project Justine - Train the trainer e.V.". Immediately after its foundation, the association applied to the Munich tax authorities for recognition as a non-profit organisation in order to be able to finance itself through private donations. This recognition will be granted in 2017.

The aim of the association is to offer vocational training to as many people as possible in Benin, West Africa, which enable them to sustainably cover their own livelihoods and thus to be able to lead an independent, self-determined life.

The main initiators of the association, Mrs Rahmée Wetterich and her sister, Marie Darouiche, run an established tailor-made shop for Dirndl in Munich under the brand "Noh Nee" with fabrics and patterns from their African homeland, the "Dirndl l'africaine". Since 2012 they had already started to train the project's namesake, Justine Tchilalou-Payarou, in Germany as a seamstress in cooperation with another association active in Benin, WEMA Home e.V. From the very beginning, it was agreed that a training centre would be set up in Benin, where Justine would pass on her knowledge as an instructor to other people in Benin – hence "train the trainer". In this way, not only help for self-help is to be practised, but knowledge and skills on the ground are to be multiplied sustainably.

The idea arose to provide a distribution channel for the pieces produced in Benin via Noh Nee in Munich. Already during Justine's second training stay in Munich in 2015 the first small test-collection "NOH NEE - made in Benin" - was launched.

"The project Justine" launches collaboration with [Google Arts and culture](#). Google Arts & Culture (formerly Google Art Project) is an online platform through which the public can view high-resolution images and videos of artworks and cultural artifacts from partner cultural organizations throughout the world.

This success and a first private trip of Rahmée Wetterich to Benin changed the perspective. This led the founders to adapt the cooperation due to the local conditions, to no longer pursue the goals as private individuals in the future, but to establish an independent organization with the association.

For the 2016 hull business year, the association initially refrained from levying membership fees, especially since the members had provided intensive benefits in kind as part of the foundation. Thus, the first homepage was created and the cornerstones for future actions were defined.
