### Annual Report 2018

In 2018, four other members joined the association; membership fees thus rose to € 1,390. At the same time, private donations increased to € 5,143 (+15.2%).

In February 2018, Rahmée Wetterich and Prof. Felix Schürmann travelled to Benin and Burkina Faso to further flesh out the construction planning. In Benin, the acquired land was precisely surveyed, the enclosure was planned and the location of individual buildings was discussed. At the same time, the search for a suitable, trustworthy contractor began. Several candidates submitted initial calculations of the expected construction costs on the basis of the existing rough plans.

In Burkina Faso, Prof. Schürmann visited Christoph Schlingensiefel's opera village to be inspired by this intercultural prestige project for his detailed planning.

The expected construction costs for the overall project – training and cultural centre, studios, housing for the trainees, sanitary and electrical infrastructure, factory sales room – subject to detailed planning – will amount to an order of magnitude of around €160,000.

After the trip, the new findings were used to plan the building in detail by Prof. Schürmann and the students of Biberach University of Applied Sciences. On the basis of this planning, the association has tried to acquire public funding.

Among other things, the planning was presented to the Federal Ministry for Economic Cooperation and Development (BMZ). From there we were forwarded to the consulting agency "Bengo Engagement Global" and to the Schmitz Foundations, both outsourced partners of the BMZ. After intensive efforts and extensive project applications, we had to take note of the fact that the project is very well classified as eligible, but that a maximum of €10,000 in funding will be granted as part of an initial application. Only in further applications can the funding amounts of more than 25,000 € be increased to up to 50,000 €.

This makes it imperative that the project is realized in several sections and that the private donations must also be increased.

Therefore, the association has initiated further fundraising events in Munich.

The [BVMW Mittelstand](#), Munich region, represented by Mr. Katejan Brandstätter, and Merkur [Privatbank Munich](#) were also able to win the first institutional sponsors.

In order to make the project accessible to a wider public, a film about the work of NOH NEE was made with the project Justine, which was broadcast on SAT.1 Regional Bayern and is also posted on the homepage [<https://theprojectjustine.com>].
